

Hyundai Hopman Cup XXIV Corporate Conditions of Sale

1. Definitions

Corporate or Corporate Package: Any or all of the packages outlined within this brochure, including Team, Patron, Penthouse, Platinum, VIP Gold and Single Session Courtside Box Packages.

2. General

Hyundai Hopman Cup reserves the right to refuse to sell Corporate Packages to any company or individual.

3. Privacy

Hyundai Hopman Cup requires the information requested on the Booking Form(s) to provide you with official Hyundai Hopman Cup Corporate Package information and related purposes, which can be reasonably expected. Your personal information will only be used in accordance with the purposes of Hyundai Hopman Cup. You will be able to access your personal information through Hyundai Hopman Cup upon reasonable notice. Hyundai Hopman Cup may use your personal information for the purposes of providing promotional material from Hyundai Hopman Cup or third parties.

4. Onselling, Advertising and Promotions

- 4.1. All Corporate Packages are issued subject to Hyundai Hopman Cup's Corporate Conditions of Sale. In particular no advertising or solicitation of Corporate Packages is permitted at any stage. Unauthorised onselling, advertising or solicitation will result in the cancellation of existing allocations whether corporate or otherwise, without the guarantee of refund.
- 4.2. Corporate Packages may not, without the prior written consent of the General Manager of the Hyundai Hopman Cup, be used for any promotion, fund raising or commercial purpose (including competition or trade promotions) or to enhance the demand for other goods and services. If a ticket is used in breach of this condition, the bearer of the ticket may be denied admission or other action may be taken against the bearer of the ticket or against the purchaser or assignee of the Corporate Package.

5. Assignment

- 5.1. Corporate Packages may be assigned to one company or individual for the length of the Corporate Package in question. Any assignment is subject to the written consent of Hyundai Hopman Cup, which reserves the right to refuse the assignment of the package. Hyundai Hopman Cup will only consider requests to assign packages where there is a firm commitment from the assignee.
- 5.2. In the event of any assignment, the original purchaser of the Corporate Package will be held responsible for the assignee and the individual holder of the allocated ticket, and will be liable to indemnify Hyundai Hopman Cup in relation to the sale and use of the tickets.
- 5.3. Any requests to assign Corporate Packages must be made in writing and directed to the General Manager, Hyundai Hopman Cup. If the request is granted, Hyundai Hopman Cup will clarify any information required with the assignee and will arrange for any signage, catering and program listings to be in the assignee's name where applicable.
- 5.4. Any assignment is on the same terms and conditions as the provision of the Corporate Package to the original Corporate Package holder.
- 5.5. Permission will not be given by Hyundai Hopman Cup for Corporate Series Packages to be broken up and sold on an individual session, or sessions, basis. Any assignment must be as one package, that is eleven sessions to the one client for Team, Patron, Platinum and VIP Gold packages.

6. Reservations

- 6.1. For existing Team, Patron, Penthouse, Platinum, VIP Gold and Single Session Courtside Box Package patrons (those who purchased Team, Patron, Penthouse, Platinum, VIP Gold and Single Session Courtside Box Packages at Hyundai Hopman Cup XXIII).
- [a] Existing clients shall be given the first option to retain the package allocated to them at Hyundai Hopman Cup XXIII, subject to Hyundai Hopman Cup's Corporate Conditions of Sale.
- [b] Packages will be reserved upon receipt by Hyundai Hopman Cup of a completed and signed Booking Form and payment as required.
- [c] Payment terms as listed on Booking Form.

- 6.2. For new Team, Patron, Penthouse, Platinum, VIP Gold and Single Session Courtside Box Package patrons:

[a] Packages will be reserved upon receipt by the Hyundai Hopman Cup of a completed and signed Booking Form and payment as required.

[b] Payment terms as listed on Booking Form.

- 6.3. Hyundai Hopman Cup will issue an invoice within 14 days of receipt of the Booking Form.

7. Payments

- 7.1. All payments received after Thursday, 1 December 2011 must be in the form of company or bank cheque, cash, or credit card (personal cheques cannot be accepted after that date).
- 7.2. All prices are exclusive of GST.

8. Tickets & Passes

- 8.1. Tickets and Passes will only be issued upon receipt of full payment.
- 8.2. Tickets and passes ordered prior to Friday, 21 October 2011 will be delivered to the nominated address in late November.
- 8.3. For reservations received after Friday, 21 October 2011, Hyundai Hopman Cup will use its best efforts to deliver tickets prior to Friday, 9 December 2011. For security purposes, tickets and passes for all reservations made after Friday, 9 December 2011 will be made available for collection from Burswood Dome at your convenience.
- 8.4. Tickets and passes will be delivered to a nominated Perth address for international clients purchasing Corporate Packages.
- 8.5. Lost or stolen tickets & passes:
- [a] may be issued on receipt of a written request specifying the number of lost tickets or passes and session details however,
- [b] lost ticket vouchers will only be available for collection from the Burswood Dome on the day of the required session.

9. Refunds & Transfers

- 9.1. All Packages are non-refundable and non-transferable.
